OCIA is the Catholic Church's process for welcoming adults and children (age 7 and older) into full communion with the faith. Whether a person is unbaptized, baptized in another Christian tradition, or baptized Catholic but not fully initiated, OCIA offers a gradual, community-based journey of faith, learning, and spiritual growth. Through distinct periods and meaningful liturgical rites, including Baptism, Confirmation, and Holy Eucharist at the Easter Vigil, participants are guided in deepening their relationship with Christ and becoming active members of the Church.

No matter where you are in life or what your story may be, know that you are welcome here. If you feel a stirring in your heart to explore the Catholic faith or return to the Church, we invite you to take this step with us. We are here to walk with you every step of the way.

To enroll in our OCIA process, the registration and required forms should be submitted by the registration deadline of August 18, 2026. We will be sharing more information about the requirements and calendar events during our sessions.

## VIRTUS SAFETY SESSION

Safe environment training is mandatory for diocesan clergy, employees and active volunteers working with youth or vulnerable adults. The Diocese of San José is devoted to the protection of children both within our Church and our communities. As we work to ensure safe environments in our parishes and schools, we also understand the importance of empowering families with information and resources that support children's safety in their home and social life as well. In recognizing the power of prevention, your child will be scheduled to attend a required virtual safety session that will cover the topic of protecting of personal boundaries, which include safe and unsafe secrets, safe and unsafe persons, safe and unsafe touches. If you do not wish your child to participate in this session, you will be required to complete and sign a waiver form.
